IV. OPEN FORUM

Resident Kyleen Gilroy – Spoke about implementing an afterschool poetry workshop for NHS students and also supported the Chad O'Brien Surf Group proposal.

Representative Theresa Tanzi presented the Committee with a Legislative Grant for \$1,800.00 to purchase uniforms and equipment for the Indoor/Outdoor track teams.

Todd Meleney of the Chad O'Brien Surf Group spoke about their proposal to donate \$150,000 to name the gymnasium after Chad O'Brien. There was discussion regarding hard wood flooring and floor surfaces which he indicates is negotiable.

V. ORAL REPORTS

1. School Committee Report

Guy deWardener informed the Committee that the NHS JV Football Team had a great season and was undefeated this year.

Mr. Ranaldi mentioned that there are 2 members from NPS Cross Country and RI Elite Team traveling to New Mexico to compete nationally.

2. Superintendent 's Report-

a. District Goals and Priorities

The Superintendent spoke about the school, district and state goals.

Discussion ensued regarding closing the gap with a completely different cohort of students. The Superintendent indicated that achievement gaps should be looked at philosophically not pragmatically. Goals are written to be reachable and then applied to school improvement teams. Common Core doesn't have to be fully implemented until 2015 and RTI will continue to be important as we are still a PBIS school system.

b. Waiver request to RIDE & School Calendar 2012-13

The Superintendent informed the Committee that she sent a letter to David Abbott, the Acting Commissioner of Education, requesting a waiver for a non-school day for NES along with a calendar. Seniors need 171 days of instruction. Graduation will not change – it will be June 13th.

c. Summer School Reports

The Superintendent reported that she enclosed Summer School Reports in the packets for NES, NPS and NHS. This year's models resulted in a big savings to the district. Dr. Nobles had questions about attendance at NES summer program.

d. Other

The Superintendent announced that Narragansett High School was honored by College Board for improved achievement in Advanced Placement test results. The AP designation is more evidence that we are not a typical school system
